### Required Documents

- Birth Certificate/Proof of Child's Age/Proof of Pregnancy with Expected Date of Delivery
- Parent/Garegiver Photo ID (Proof of Residency required if ID does not have Nueces Address)
- Gurrent Income
   (Most Recent Tax Return, W2, Child Support, Social
   Security, Unemployment, Grants/ Scholarships, and/or
   any other income received in the last year)
   \*income must be verified for 12 months\*

#### -Automatically qualify if:

- Gurrently receiving SNAP, TANF, or SSI
- Foster Parent/Caregiver of child applicant

(If automatically qualifying is applicable, income is not required, however, current documentation to provide proof of benefit is required)

- Proof of Parent/Caregiver's Current
